Here are some additional general first aid requirements for a construction site:

- 1. First aid kits: Easily accessible and fully stocked with essential supplies.
- 2. Trained first aiders: On-site personnel trained in first aid and emergency response.
- 3. Emergency phone: Access to a phone or two-way radio for emergency calls.
- 4. Stretchers and backboards: For transporting injured workers.







- 5. Eye wash stations: For flushing out chemicals or debris.
- 6. Safety showers: For decontaminating workers exposed to chemicals.
- 7. Burn cream and gel: For treating burns.
- 8. Automated External Defibrillator (AED): For cardiac emergencies.
- 9. Oxygen supply: For workers experiencing respiratory distress.
- 10. First aid room or area: A designated space for treating injuries and illnesses.
- 11. Medical waste disposal: Proper disposal of medical waste and sharps.
- 12. Confidential medical records: Maintaining workers' medical records and confidentiality.
- 13. Regular first aid training and drills: Ensuring first aiders are up-to-date and prepared.
- 14. Incident reporting and documentation: Accurate reporting and documentation of incidents and injuries.
- 15. Communication plan: Establishing a communication plan for emergency situations.
- 16. Emergency services information: Posting contact information for local emergency services.
- 17. Site-specific hazards and procedures: Including site-specific hazards and procedures in the first aid plan.
- 18. Regular inspections and audits: Regularly inspecting and auditing the first aid provisions and procedures.
- 19. Worker participation and feedback: Encouraging worker participation and feedback on the first aid program.
- 20. Compliance with regulations and standards: Ensuring compliance with relevant regulations and standards.
